# Opening, part one

One of the most controversial topics is the vaccinations issue.

The questions that all of us need to ask are they safe? Do they protect us from getting the disease?

Before we explore this topic in further detail, several facts need to be shared with everyone.

One, the U.S. among developed countries has one of the highest infant mortality rates.

Two, the U.S. among developed countries has one of the highest maternal mortality rates.

Three, the life expectancy for Americans is actually declining, not remaining stable or increasing.

Four, this country spends more on health care than on any other country in the world.

Five, medical bills are the major reason for bankruptcies.

Six, what does this have to do with vaccinations. What is our government doing about these statistics? These are the questions we all need to ask about.

# Opening, part two

- A vaccine for every health issues, that seems like an great answer to defeat disease. Does it promote health at the same time? Is more better than less?
- We are deluged by the mass media and even by medical protocol, have you had your flu shot or is it time for you to have the tetanus shot every time we seek medical care, even in an urgent care setting?
- Meanwhile, there is a growing body of literature on alternative methods that can help us be healthier. It is really about strengthening the immune system. This can be done via nutrition and detoxification.
- The purpose of this presentation is to help people understand the various issues associated with vaccinations

Note: This presentation is not covering vaccinations recommended for travel to various parts of the world.

# History of Vaccinations

- One, the practice of vaccinations actually goes back as far as 1000 AD, by the Chinese for smallpox.
- Two, the practice of vaccinating against smallpox started in the 1600's and become more common in the 1700's in Europe.
- Three, even as early as 1926, there was opposition to mandatory vaccination of smallpox.
- Four, however, vaccination against smallpox was successful and this led to the practice of creating other vaccines for other infectious diseases.

# Five Lies Regarding Vaccinations

- One, is the herd immunity - A situation in which a sufficient proportion of a population is immune to an infectious disease (through vaccination and/or prior illness) to make its spread from person to person unlikely. Even individuals not vaccinated (such as newborns and those with chronic illnesses) are offered some protection because the disease has little opportunity to spread within the community.
- Two, putting other children at risk – Shedding can occur after a live-virus vaccination, this means that the vaccinated person can be spreading the virus to non-vaccinated to others.
- Three, vaccines are safe and effective - There are zero studies on this.
- Four, everyone should get the flu shot - Actually, the flu shots contain mercury and may also have aluminum.
- Five, newborns need the Hep B vaccine – Hep B vaccine contain aluminum and formaldehyde, as well as a trace of mercury. It should not be given to newborns.

# Theories

- One – One theory is that it is germs that cause disease and are the problem. Note: As sanitation improved, this also improved health issues.
- Two-When we are exposed to a substance that can cause harm, the body creates antibodies so that the next time that we are exposed to it, our immune system is ready to fight the offending substance. Note: In homeopathic medicine, minute exposure can trigger a positive immune response.
- Three-Dr. Ronald P. Drucker, DC (DC stands for Doctor of Chiropractor) mentions two French scientists who lived at the time of Louis Pasteur. One was Antoine Bechamp, MD, PhD. a French researcher and cell biologist. He said " Germs do not cause disease in the real sense. Something happens in the body to allow the germ to become invasive."



# Theories continued

- Three continued: Another French scientist, Claude Bernard developed the following theory, "if the internal terrain was inhospitable place for disease to flourish, then the disease could never take over the host". Basically, both of these scientists were saying that it was the environment or the body's immune system that places a critical role in keeping unhealthy micro-organisms at bay in the body. Germs in of themselves are not the cause of disease. What makes us sick is an immune system unable to fend off harmful substances. However, allopathic medicine focused on as germs being the bad guys and the target. - Four- What is important is strengthening the immune system so that it can fight off various diseases and other harmful ingredients. What can strengthening the immune system are vitamins, minerals, and enzymes and pre and pro biotics. Note: That is what functional and naturopathic medicine is based on.

# Current Situation on Vaccines in the U.S.

- This is a case where one needs to know the facts, especially when it comes to the wellbeing and health of the next generation. This is especially true when it comes to the vaccination issues.
- No US federal vaccination laws exist, but all 50 states have laws requiring children attending public school to be vaccinated against diphtheria, tetanus, and pertussis (generally in a DTaP vaccine); polio (an IPV vaccine); measles and rubella (generally in an MMR vaccine); and varicella (chickenpox).
- All 50 states have legislation requiring specified vaccines for students. Although exemptions vary from state to state, all school immunization laws grant exemptions to children for medical reasons. There can be religious and philosophical reasons, too.
- It needs to be noted that vaccines do not necessarily provide life long immunity whereas actually getting the measles as a child does provide life long immunity.

# Vaccine Injury Court of the U.S. Government

- **National Vaccine Injury Compensation Program**

- The **National Vaccine Injury Compensation Program (VICP or NVICP)** was established by the 1986 National Childhood Vaccine Injury Act (NCVIA), passed by the United States Congress in response to a threat to the vaccine supply due to a 1980s scare over the DPT vaccine. Despite the belief of most public health officials that claims of side effects were unfounded, large jury awards had been given to some plaintiffs, most DPT vaccine makers had ceased production, and officials feared the loss of herd immunity. <sup>1</sup>
- It was President Ronald Reagan who signed the legislation signed away the rights of Americans to sue vaccine manufacturers, and instead, sue the U.S. Government.
- As of October 2019, \$4.2 Billion in compensation (not including attorneys fees and costs) has been awarded over the forty-three year history of the program.

Note #1: The burden of proof rests with the patient or the patient's family.

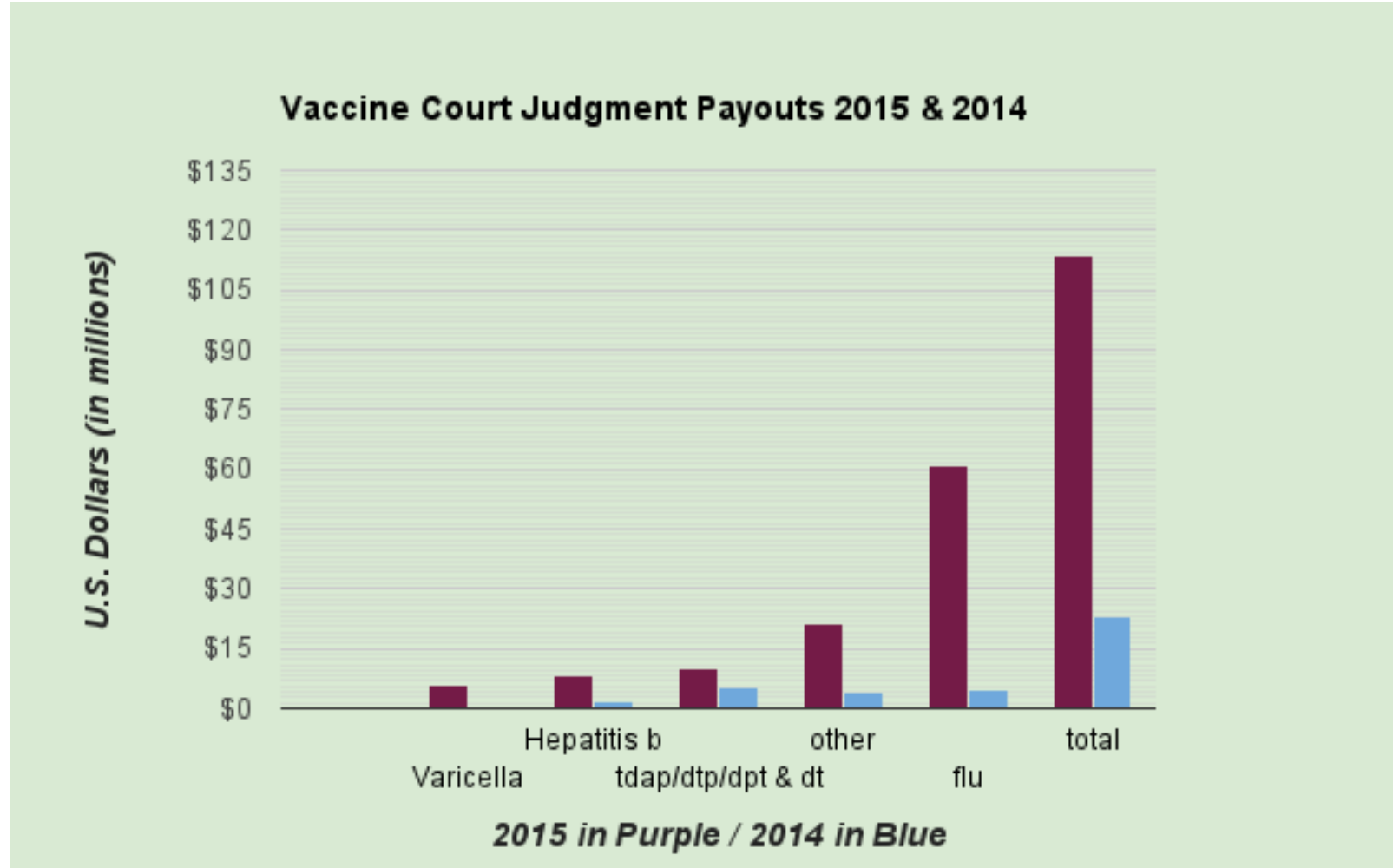
Note #2: Not everyone harmed by vaccinations is compensated.

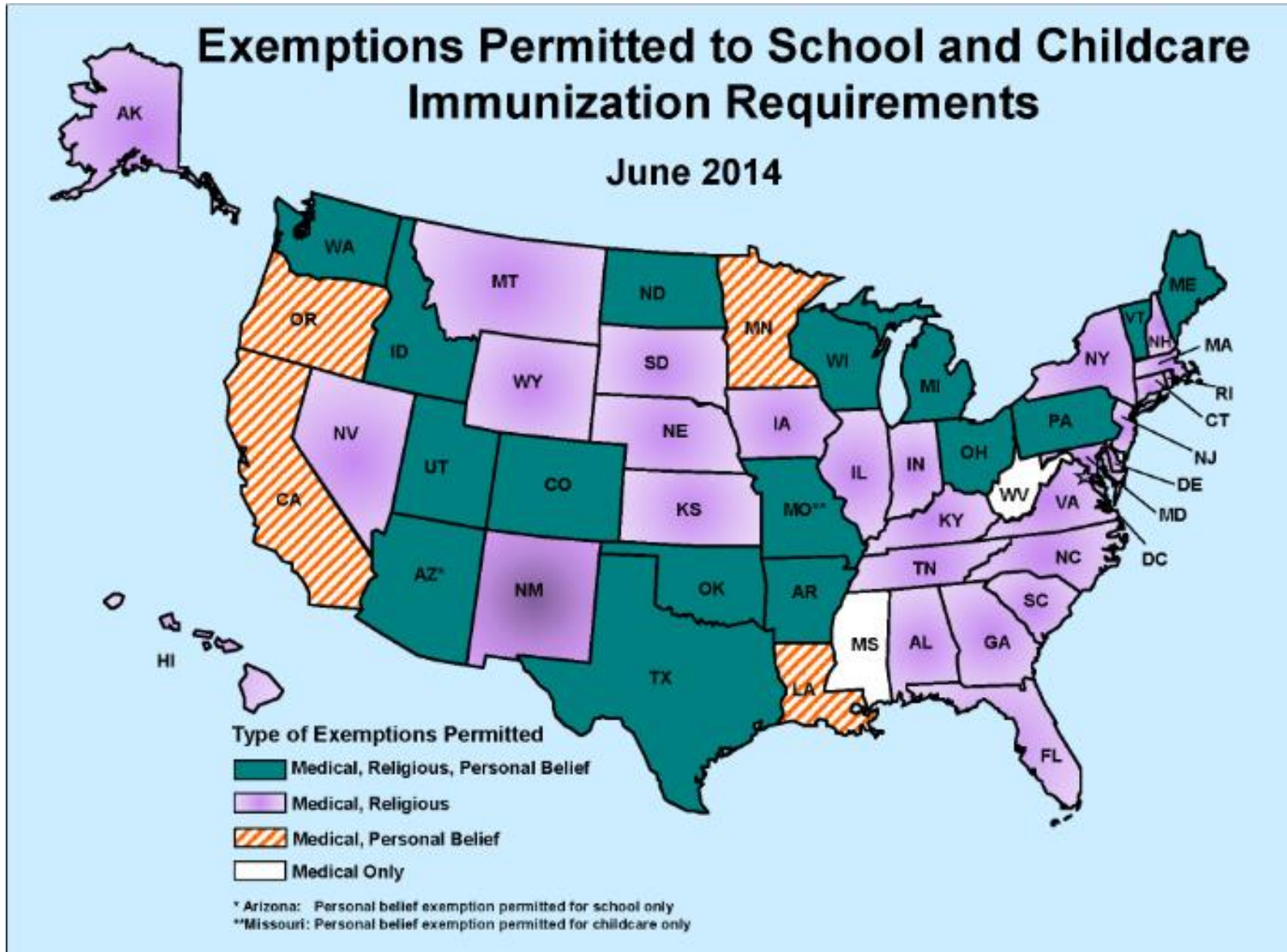
Note #5: It is time to reassess this law.

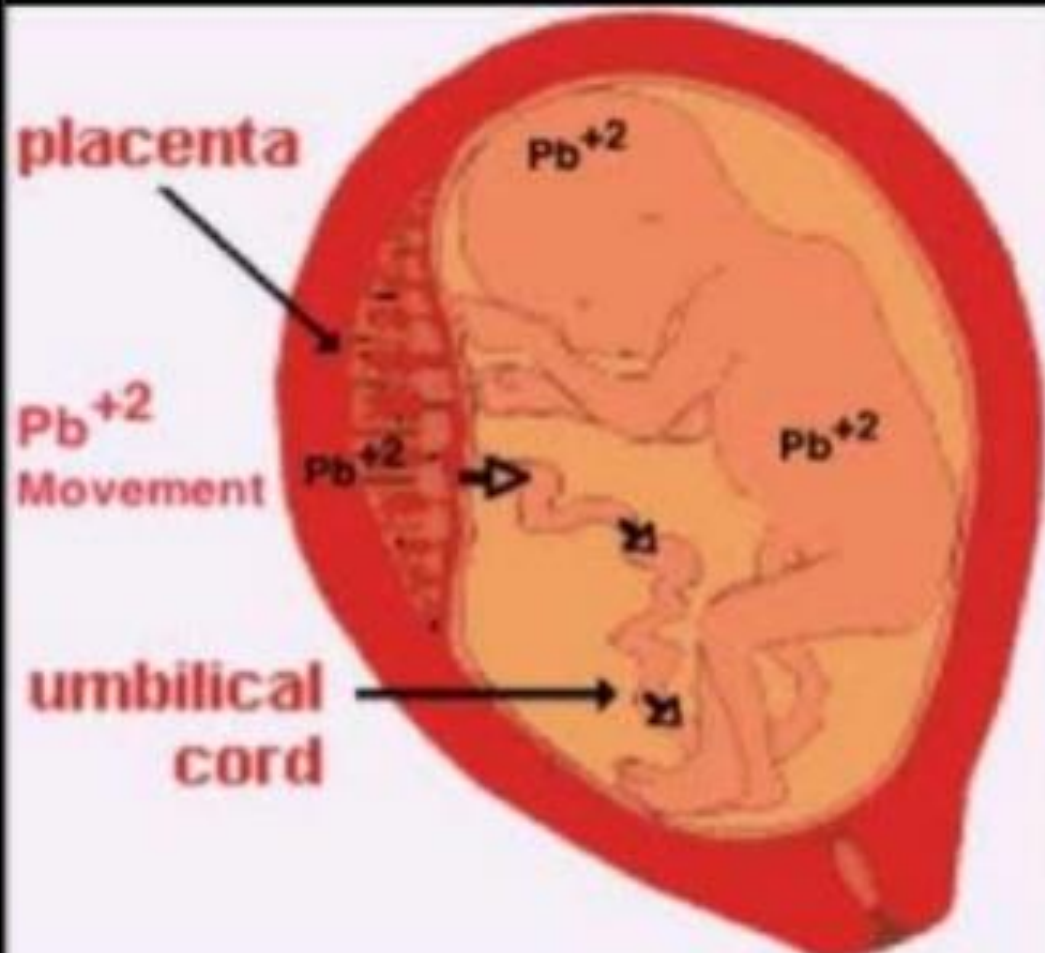
# Exemptions Chart in the U.S. as of June 2014

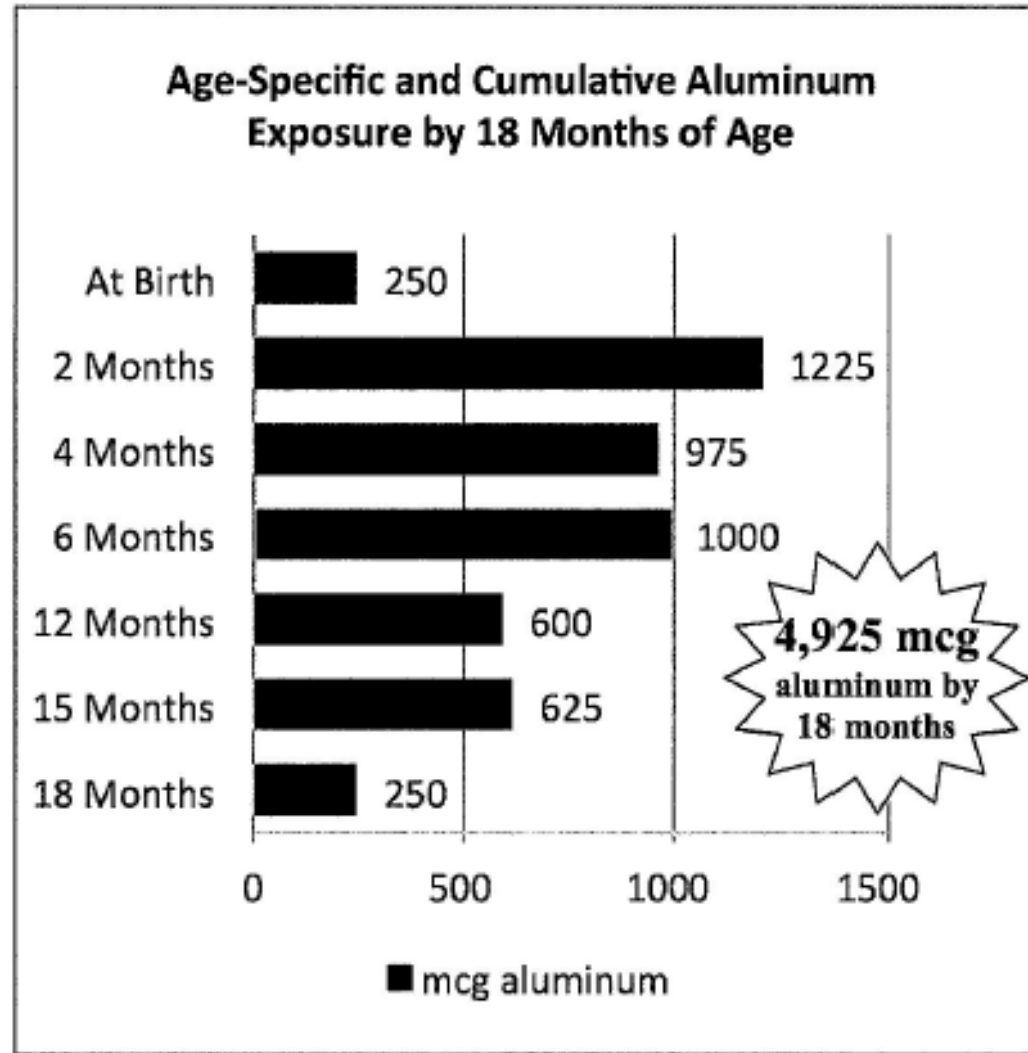

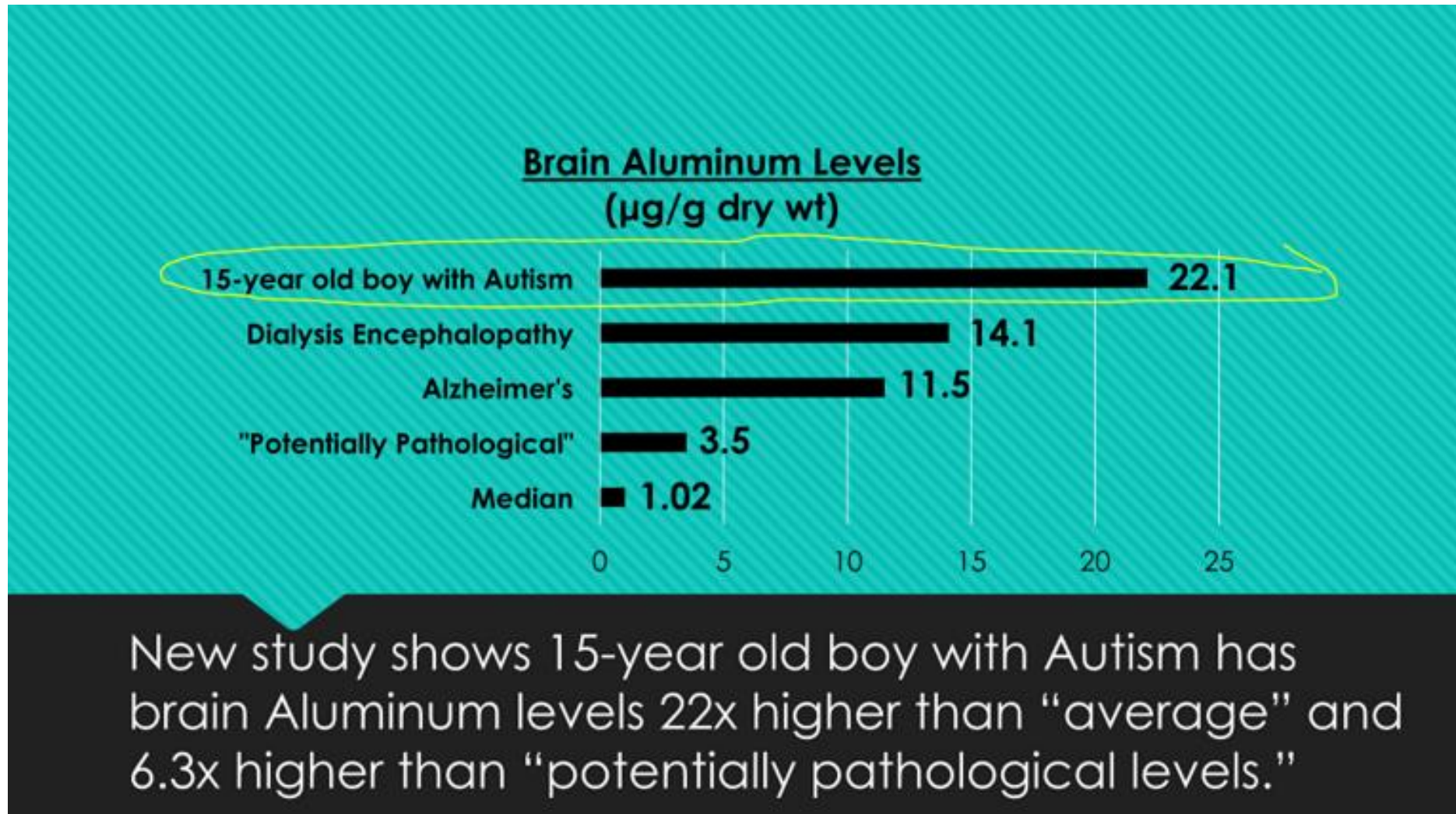

# Addendum: Autism Facts

- About 1 in 59 children has been identified with autism spectrum disorder (ASD) according to estimates from CDC's Autism and Developmental Disabilities Monitoring (ADDM) Network. (Note: It now appears to be 1 in 45 children as of 2019)
- ASD is reported to occur in all racial, ethnic, and socioeconomic groups.
- ASD is about 4 times more common among boys than among girls.
- Studies in Asia, Europe, and North America have identified individuals with ASD with an average prevalence of between 1% and 2%.
- About 1 in 6 children in the United States had a developmental disability in 2006-2008, ranging from mild disabilities such as speech and language impairments to serious developmental disabilities, such as intellectual disabilities, cerebral palsy, and autism.

# Addendum: Autism Information

- Autism spectrum disorder (ASD) is a developmental disability that can cause significant social, communication and behavioral challenges. There is often nothing about how people with ASD look that sets them apart from other people, but people with ASD may communicate, interact, behave, and learn in ways that are different from most other people. The learning, thinking, and problem-solving abilities of people with ASD can range from gifted to severely challenged. Some people with ASD need a lot of help in their daily lives; others need less.
- A diagnosis of ASD now includes several conditions that used to be diagnosed separately: autistic disorder, pervasive developmental disorder not otherwise specified (PDD-NOS), and Asperger syndrome. These conditions are now all called autism spectrum disorder.
- Learning disabilities and hyperactivity can also be considered part of the autism spectrum disorder. (Note: This represents a major issue for public education.)

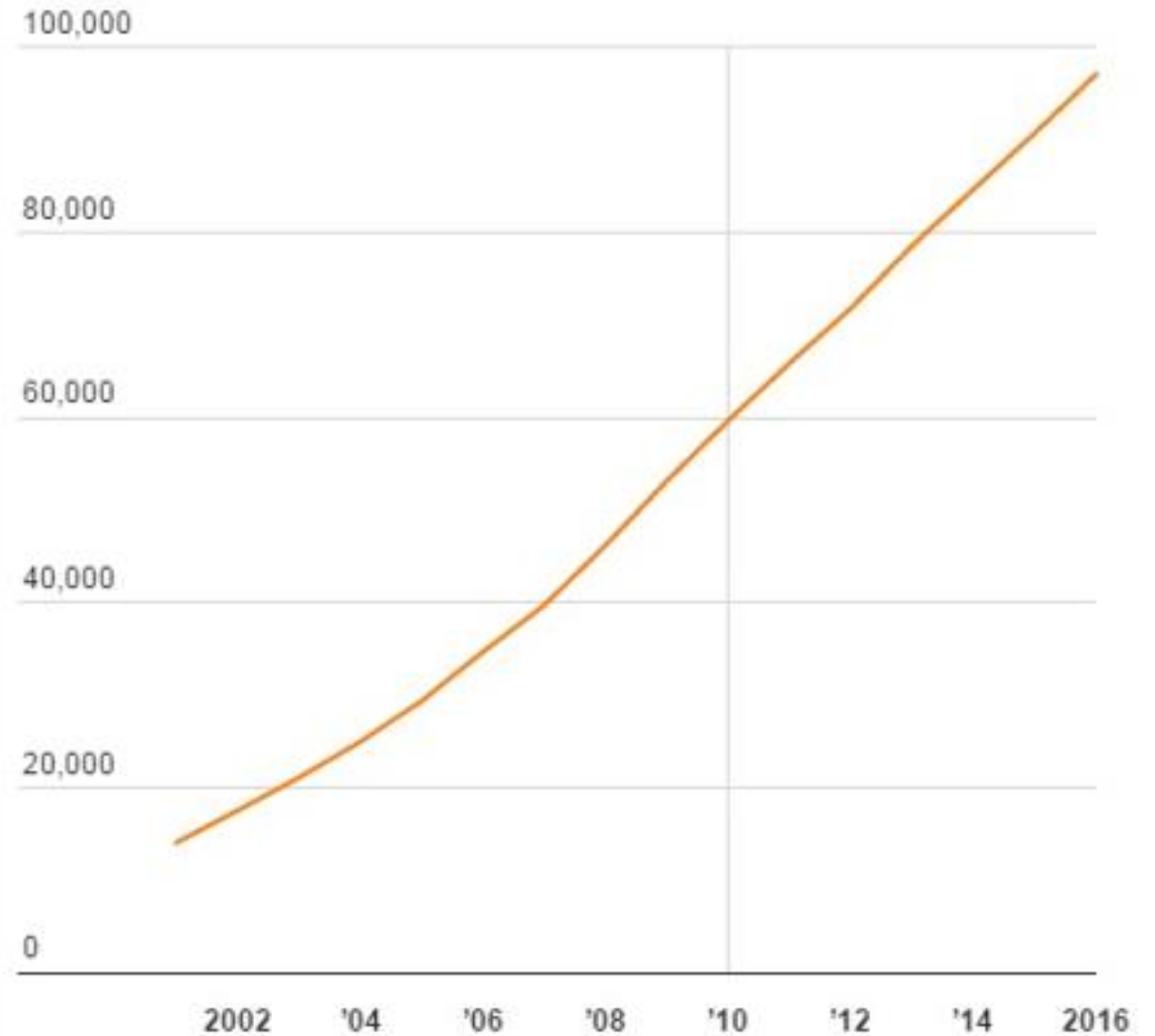

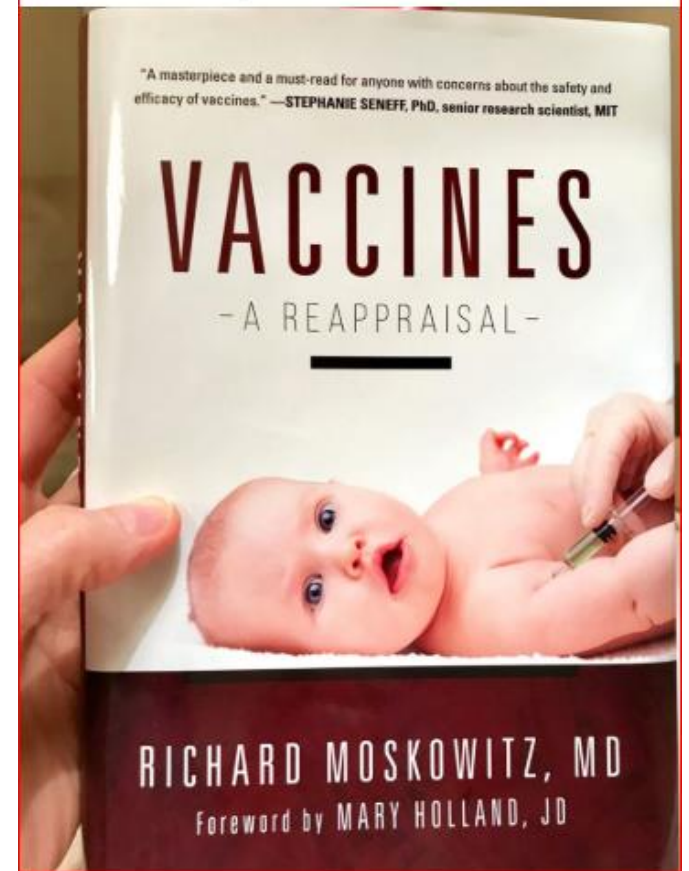

# Addendum: Glossary and Concepts

- Adjuvant - A substance (e.g. aluminum salt) that is added during production to increase the body's immune response to a vaccine. Aluminum is an example of an adjuvant.
- Allergies - A condition in which the body has an exaggerated response to a substance (e.g. food or drug). Also known as hypersensitivity.
- Antibiotics - Antibiotics, like neomycin, help keep outside germs and bacteria from growing in the vaccine.
- Antigens - They are very small amounts of weak or dead germs that can cause diseases. They help your immune system learn how to fight off infections faster and more effectively. The flu virus is an example of an antigen.
- Autoimmune diseases – This is when the immune system attacks an area of the body or organ (attacking itself).
- Bioaccumulation – This occurs when specific substances accumulate in the body's tissues.
- Cell culture (growth) material – An example are eggs that enable vaccines antigens to grow.

# Addendum: Glossary and Concepts continued

- Compromised immune system – Children and adults that have compromised immune systems, vaccinations pose a greater harm and even death. This is one reason that it is not a good idea or really safe for pharmacies to administer vaccinations as they do not have the medical knowledge of the person receiving the vaccine, especially the flu shot.
- Encephalitis - Inflammation of the brain caused by a virus. Encephalitis can result in permanent brain damage or death.
- Epidemiological Studies and Research – It is looking at the health outcomes of a specific community.
- Epigenetics – The interaction of the environment and genetics on health.
- Immune Systems - Unlike other systems in the body, the immune system is a system of cells that communicate with each other. Also, part of the immune system is located in our gut and intestines.
- Immune system for adults versus infants – The immune system is quite different for adults (more mature) versus one for infants.
- Inactivating (germ-killing) ingredients – These ingredients, like formaldehyde, are there to weaken or kill viruses, bacteria, or toxins in the vaccine.

# Addendum: Glossary and Concepts continued

- Informed consent – This occurs when the health provider informs the patient the benefits as well as the risks with a specific medical protocol before performing it.
- Nagalase - GcMAF is a vitamin protein found naturally in the body. However, if cancer forms in the body, these defensive cells and their functions can be blocked. Cancer cells and tumors release a protein called nagalase. When released, it prevents immune system cells from functioning properly.
- Neurotoxins – These are toxic chemicals that are harmful to the brain.
- Preservatives – One is thimerosal. It's role is to protect the vaccine from outside bacteria or fungus. Today, preservatives are usually only used in vials (containers) of vaccines that have more than 1 dose. That's because every time an individual dose is taken from the vial, it's possible for harmful germs to get inside. Most vaccines are also available in single-dose vials and do not have preservatives in them.
- Risk Factors – Is a measurement of the potential harm of a specific vaccine or medical protocol.
- Shedding – To discharge usually gradually from the body exposed persons may **shed** virus from the oropharynx. The oropharynx is part of the throat that is at the back of the mouth, This can include people with recent vaccinations.

# Addendum: Glossary and Concepts continued

- Stabilizers - Stabilizers, like sugar or gelatin, help the active ingredients in vaccines continue to work while the vaccine is made, stored, and moved. Stabilizers prevent the active ingredients in vaccines from changing because of something like a shift in temperature where the vaccine is being stored can affect the vaccine.
- Sudden Infant Death Syndrome (SIDS) - The sudden and unexpected death of a healthy infant under 1 year of age. A diagnosis of SIDS is made when an autopsy cannot determine another cause of death. The cause of SIDS is unknown. Also known as “crib” or “cot” death.  
(Presenter’s note: If the SIDS occurs shortly after vaccination, the vaccines can be considered the cause.)
- Variolation - Variolation or inoculation was the method first used to immunize an individual against smallpox (Variola) with material taken from a patient or a recently variolated individual, in the hope that a mild, but protective, infection would result.
- Vaccine Adverse Event Reporting System (VAERS) - A database managed by the Centers for Disease Control and Prevention and the Food and Drug Administration. VAERS provides a mechanism for the collection and analysis of adverse events associated with vaccines currently licensed in the United States. Reports to [VAERS](#) can be made by the vaccine manufacturer, recipient, their parent/guardian or health care provider. For more information on VAERS call (800) 822-7967.

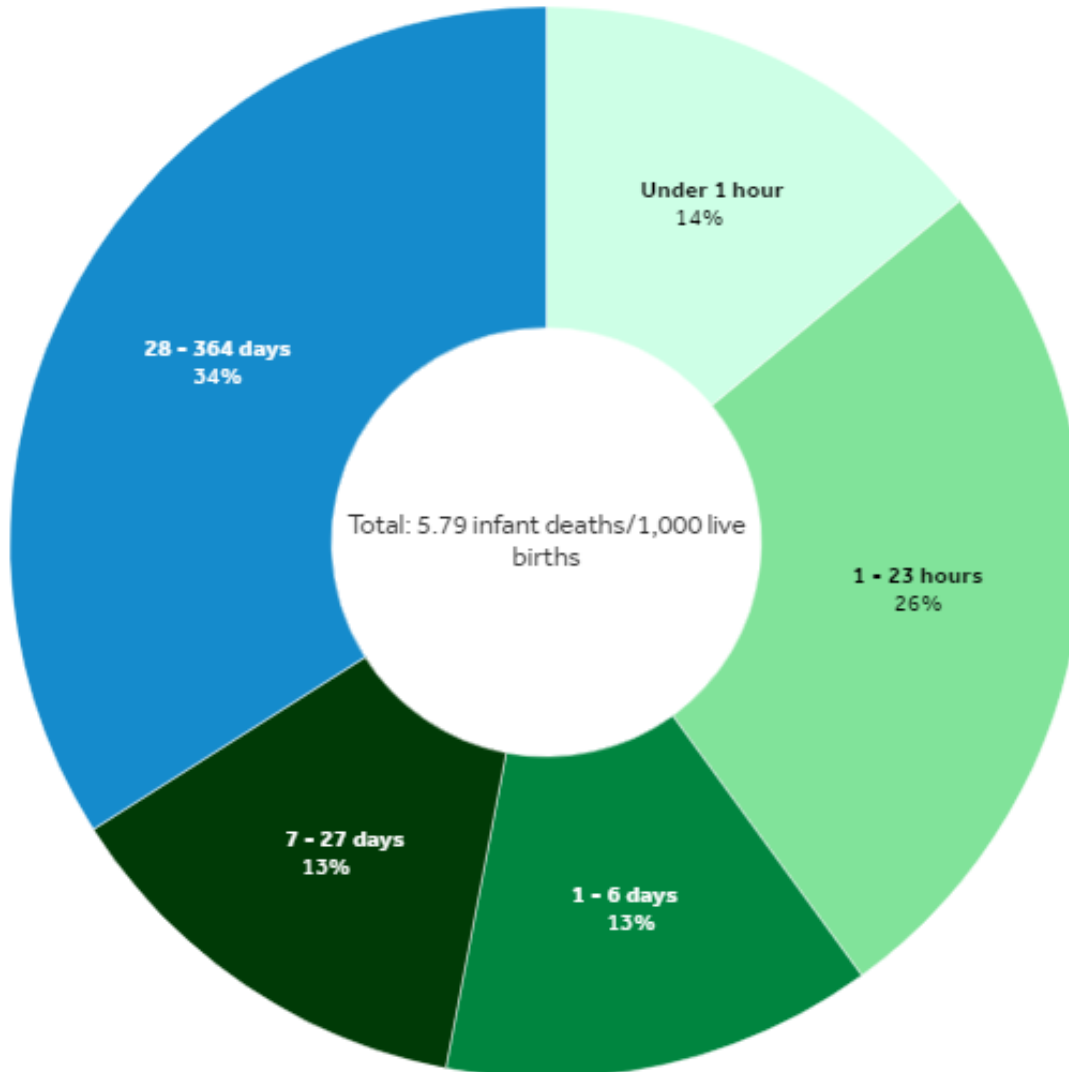

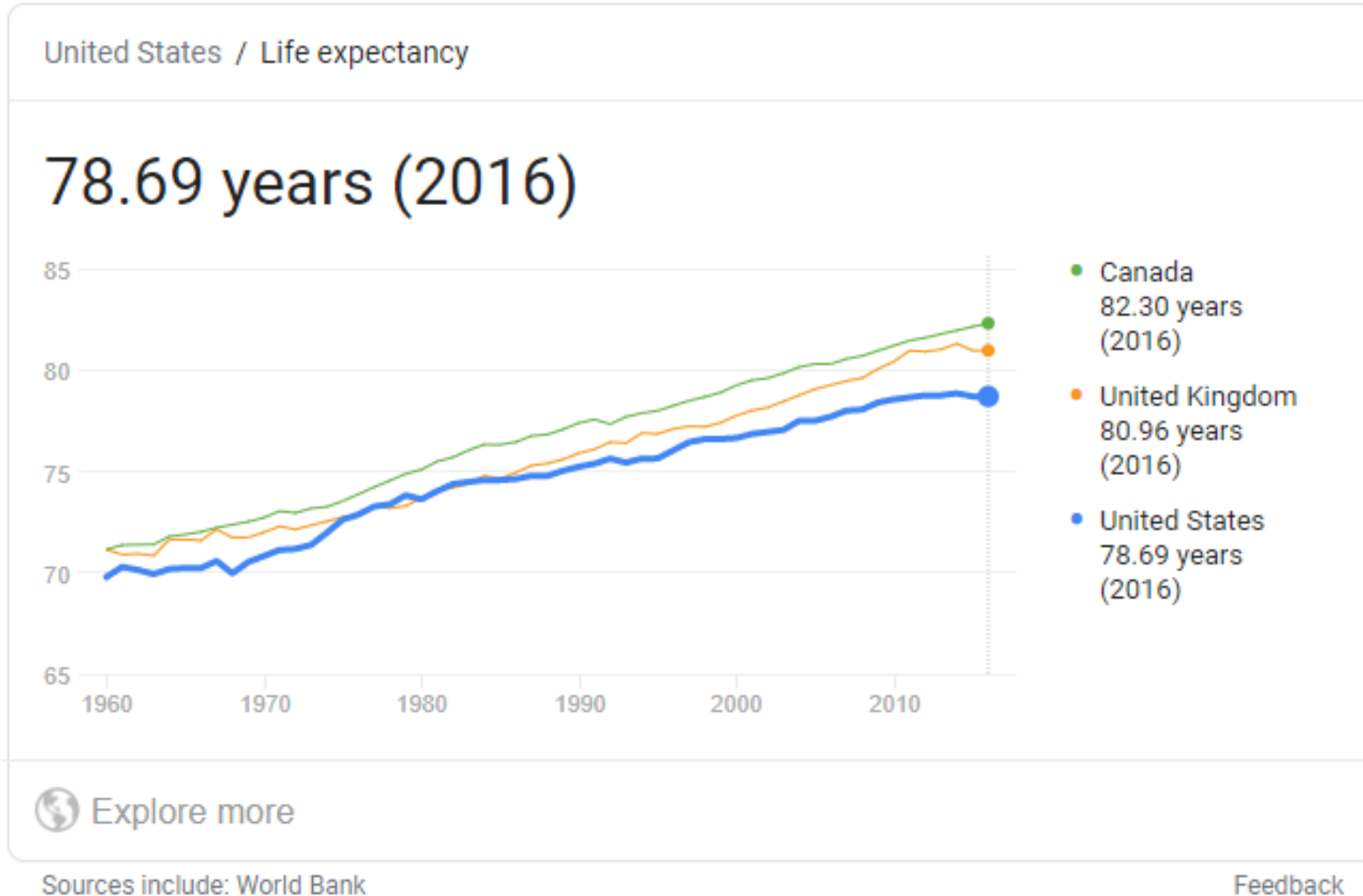

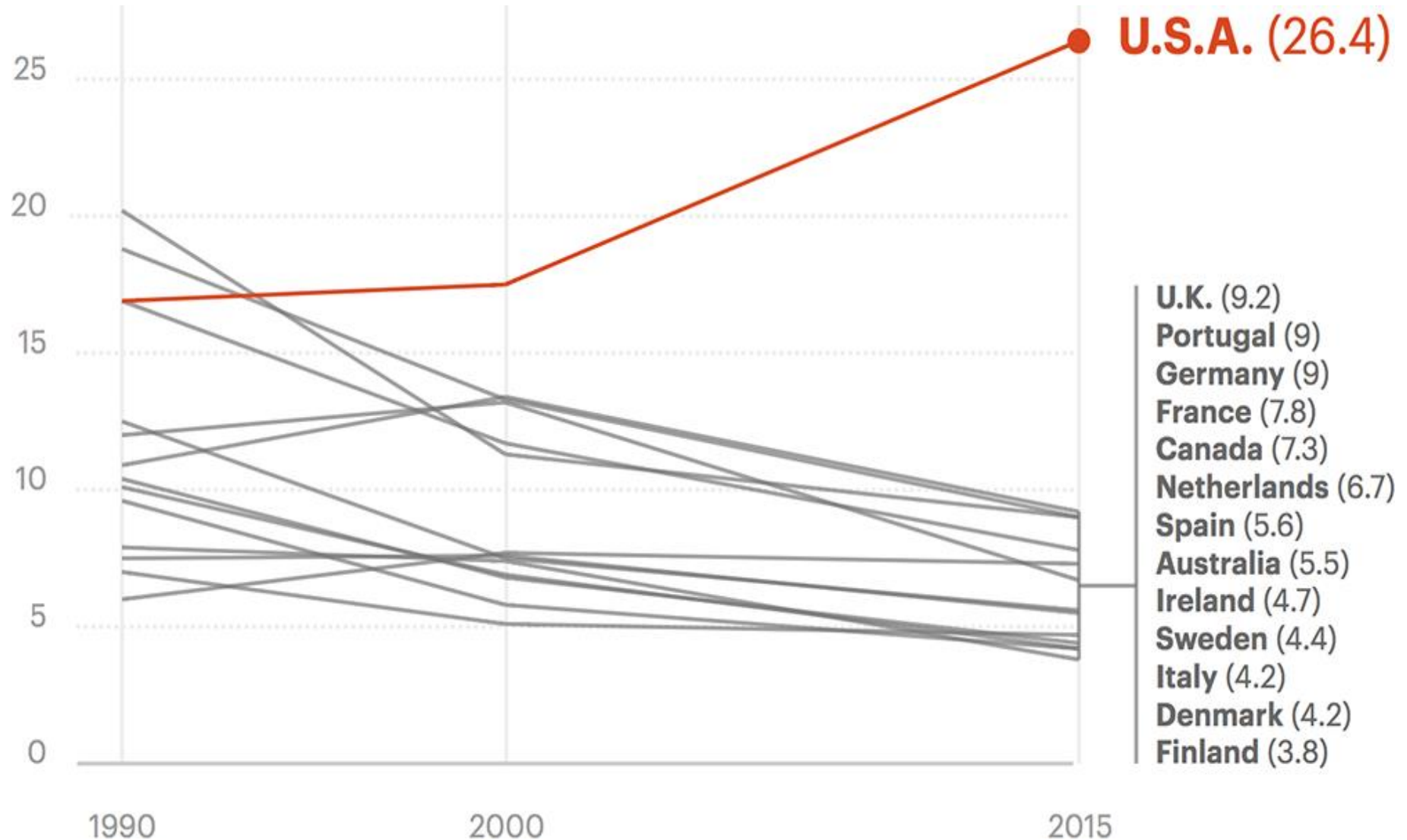
# Addendum: Issues with Vaccines

# Addendum: Risk Factors

- Concerns on vaccine safety is not just limited to the United States.
- When serious side effects occur, especially death of a child, after a vaccination, multiple vaccines, or a series of vaccines, this affects the public trust in the vaccine protocol.
- Below are four levels of risk:
  - Common – More than 1 in 100 doses
  - Less Common – 1 in 100 to 1 in 100,000 doses
  - Rare – 1 in 100,000 to 1 in 1 million
  - Inconclusive – Not enough data
- One suggestion (by the presenter) is that the research does not include the epidemic of autoimmune diseases and allergic reactions in the U.S. Also, epidemiological studies can pinpoint which populations are not developing autism as an example whereas others are.
- Two, from an ethical point of view, we need to reconsider the safety of vaccinating infants, when their immune systems are not on the same level of an adult.
- Three, the adjuvants and other additives in vaccines also need to be reassessed for their impact on the health of infants and children.
- Four, more studies can be done on strengthening the immune system so that these so called dangerous diseases are less problematic.

# Addendum: Specific Vaccines – Flu Vaccine

- One of the most commonly required (or asked by medical professionals) is whether or not you have had the flu shot. Apparently, every year, one needs a flu shot as the flu strains change over time.
- However, the flu shot contains mercury, a heavy metal that is extremely toxic and it can be assessed by advanced mass spectrometry technology.
- Vaccines have been found to contain 25,000 times more mercury than is legally allowed in drinking water by the EPA, Environmental Protection Agency.
- Babies born to mothers who refused the flu vaccine fared better than those that did receive the flu vaccine.

# Addendum: Specific Vaccines – Flu Vaccine continued

- Another article covers issues with the flu shots.
- One, the flu shot contains over 50 ppm mercury, which is linked to kidney failure, birth defects, spontaneous abortions, and neurological damage. It is 25,000 times higher than the EPA limit of mercury in drinking water.
- Only one insert is available in the ten vial package, so only one out of the ten people have access to the package information.
- Safety of the flu shot has not been proven in pregnancy and children.
- These shots are administered without informed consent, the right of all of us to know the benefits and risks involved with any particular vaccine.
- Other ingredients found in the flu shot include aluminum, antibiotics, egg protein, formaldehyde, and MSG besides thimerosal (mercury containing preservative).

# Addendum: Specific Vaccines – Flu Vaccine continued – Adverse Symptoms

- Adverse symptoms especially for the elderly can include:
- Anaphylaxis (life-threatening, whole-body allergic reaction)
- Brachial neuritis (excruciating unilateral shoulder pain, followed by paralysis of shoulder)
- Chest pain
- Convulsions, fainting, and dizziness.
- Difficulty breathing
- Facial palsy/Bell's palsy
- Guillain Barre syndrome, myelitis (spinal cord inflammation)
- Lymphadenopathy (enlarged lymph nodes)
- Optic neuritis (inflammation of the optic nerve)
- Paresthesia (tingling/numbness of the skin)  
Itchy skin
- Pharyngitis and rhinitis (inflammation of the throat or pharynx and the nose, respectively)
- Stevens-Johnson syndrome
- Thrombocytopenia (low platelet count)
- Vasculitis (inflammatory destruction of blood vessels)

- Note: This may also happen with other vaccines.

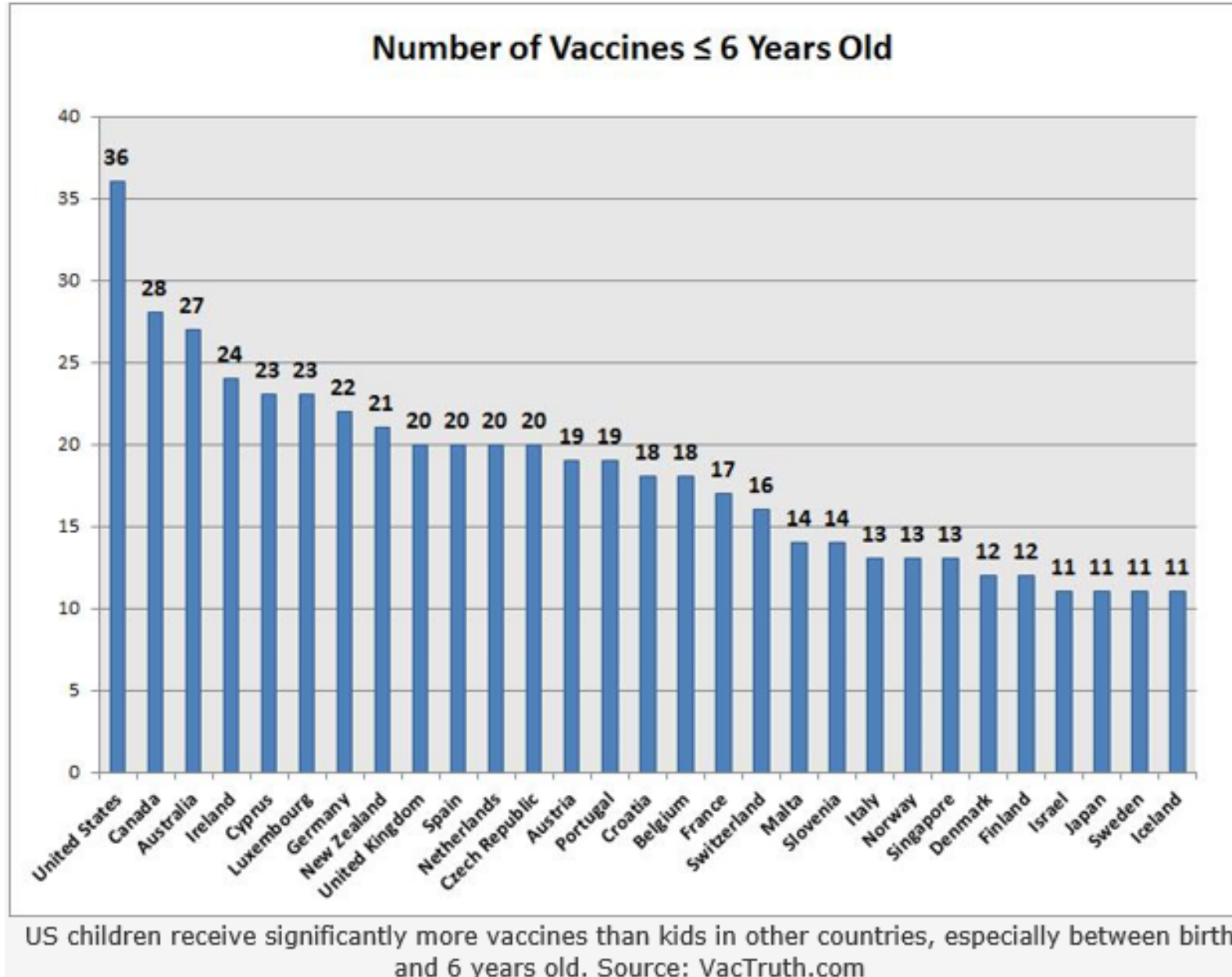

# Addendum: Statistics

- Today, 1 child in 5 is learning disabled; in 1976, it was 1 in 17.
- Today, 1 child in 6 under age eight, 1 in 2 adolescents, and 1 in 4 young adults is diagnosed with a mental, behavior or emotional disorder.
- There has been an unexplained 55 percent increase in depression and anxiety in children since 2003.
- Today, 1 child in 13 has a food allergy, often life threatening, and food allergies have increased 50 percent among children since 1997.

# Addendum: Types of Vaccines

- Acellular vaccine: A vaccine containing partial cellular material as opposed to complete cells.
- Attenuated vaccine: A vaccine in which live virus is weakened (attenuated) through chemical or physical processes in order to produce an immune response without causing the severe effects of the disease. Attenuated vaccines currently licensed in the United States include measles, mumps, rubella, varicella, rotavirus, yellow fever, smallpox, and some formulations of influenza, shingles, and typhoid vaccines. Also known as a *live vaccine*.
- Booster shots: Additional doses of a vaccine needed periodically to “boost” the immune system. For example, the tetanus and diphtheria (Td) vaccine which is recommended for adults every ten years.
- Combination vaccine: Two or more vaccines administered in a single dose in order to reduce the number of shots given. For example, the MMR (measles, mumps, rubella) vaccine.


# Addendum: Types of Vaccines continued

- Inactivated vaccine: A vaccine made from viruses and bacteria that have been killed through physical or chemical processes. These killed organisms cannot cause disease.
- Investigational vaccine: A vaccine that has been approved by the Food and Drug Administration (FDA) for use in clinical trials on humans. However, investigational vaccines are still in the testing and evaluation phase and are not licensed for public use.
- Live vaccine: A vaccine in which live virus is weakened (attenuated) through chemical or physical processes in order to produce an immune response without causing the severe effects of the disease. Live vaccines currently licensed in the United States include measles, mumps, rubella, varicella, rotavirus, yellow fever, smallpox, and some formulations of influenza, shingles, and typhoid vaccines. Also known as an *attenuated vaccine*.
- Polysaccharide vaccines: Vaccines that are composed of long chains of sugar molecules that resemble the surface of certain types of bacteria. Polysaccharide vaccines are available for pneumococcal disease, meningococcal disease and *Haemophilus Influenzae* type b.

# Addendum: Vaccine Harm


**Early Warning Signs**

**Neurotoxins in vaccines can cause cranial nerve damage. These are the most common. Photograph your child's face before and after shots to document their injury.**




**1. Crooked Smile**

If your child develops a Crooked Smile 7 weeks after birth, they will not be able to smile evenly. Only one side of their face will pull up. One eye will be stronger than the other.




**3. Outward-turned Eye**

# Addendum: Vaccines for Dogs

- **ESSENTIAL VACCINATIONS FOR YOUR DOG**
- **Distemper, Hepatitis, Parainfluenza and Parvovirus (DHPP).** Commonly called the “distemper shot,” this combination vaccine actually protects against the four diseases in its full name.
- **Rabies.** Rabies virus is fatal and all mammals, including humans, are susceptible to infection. Rabies vaccinations for dogs are required by law in most states.
- **OTHER VACCINES FOR DOGS**
- Your veterinarian may also recommend other vaccines for your dog depending on where you live and your dog’s lifestyle:
- **Leptospirosis.** Often included as part of the distemper combination vaccine (making it a DHLPP), this bacterial infection is most prevalent in moist climates where there are areas of standing or slow-moving water. This disease can also be spread from animals to humans.
- **Bordetella (commonly called “kennel cough”).** The bordetella virus causes an extremely contagious upper respiratory infection. Your veterinarian may recommend this vaccine before your dog goes to a dog park, groomer, boarding kennel, doggie daycare or dog show.
- **Lyme Disease.** A bacterial infection carried by ticks, this disease is extremely prevalent in certain parts of the country — in particular, the east and west coasts and the areas around the Great Lakes.
- **Canine Influenza.** This viral upper respiratory disease originated at a Florida racetrack in 2004 and has quickly spread across the country. Outbreaks are prevalent in animal shelters and boarding kennels.
- **Corona Virus.** This virus infects the intestinal tract and is more prevalent in the southern United States.



# Addendum: Vaccines for Cats

- **ESSENTIAL VACCINES FOR YOUR CAT**
- **Feline Viral Rhinotracheitis, Calicivirus and Panleukopenia (FVRCP).** Commonly called the “distemper” shot, this combination vaccine protects against three diseases: feline viral rhinotracheitis, calicivirus and panleukopenia (sometimes called “feline distemper”).
- Rabies. Rabies virus is fatal and all mammals, including humans, are susceptible to infection. Rabies vaccinations for cats are required by law in most states.
- **OTHER VACCINES FOR CATS**
- Your veterinarian may also recommend other vaccines for your cat depending on where you live and your cat’s lifestyle:
- **Chlamydia.** Chlamydia is a bacterial infection that causes severe conjunctivitis, and the vaccination for it is often included in the distemper combination vaccine (making it an FVRCP-C).
- **Feline Leukemia (Felv).** Felv is a viral infection that is only transmitted through close contact, and this vaccine is generally only recommended for cats that go outdoors.
- **Feline Immunodeficiency Virus (FIV).** FIV is a viral infection that is only transmitted through close contact, and this vaccine is generally only recommended for cats that go outdoors.
- **Feline Infectious Peritonitis (FIP).** A viral infection most common in catteries and feral colonies, FIP is almost always fatal. Most house cats do not have a significant risk of contracting this disease.
- **Bordetella.** This bacteria causes highly contagious upper respiratory infections. Your veterinarian may recommend this vaccine before your cat goes to a boarding kennel or groomer.
